Dear friends,

is with great pleasure that I here present the latest issue of the Europe Zone newsletter.

As you know, the latest two months have been characterized by a series of **dramatic events in Central Asia**, which have deeply involved both the countries of Kyrgyzstan and Uzbekistan. The massive population movement and the resulting humanitarian scenario have demanded prompt action by the Red Cross Red Crescent, as well as strong and consistent coordination among all the Movement actors involved, in order to ensure an effective humanitarian response.

The situation, though, remains highly fragile and it is not yet time to praise ourselves for our successes, nor even blame ourselves for what we could have done better. More work needs doing and stronger cooperation with ICRC as well as the Red Crescent Societies is required, in order to avoid that what one month ago was dreaded as an "alarming humanitarian crisis" will ever take a similar turn. When a disaster occurs, the role of the Red Cross Red Crescent Movement is not only to save lives, protect the affected people and strengthen recovery. Such emergencies should also remind us of our role to address the causes of vulnerability, by advocating for the needs and rights of vulnerable people, through the use of humanitarian diplomacy and in respect of our Fundamental Principles. And make it so that in the future our action will no longer be needed.

In the meanwhile, in **Central and Eastern Europe** significant joint efforts still need doing to support the people who have been affected by the **floods** which struck large swathes of the region in the last months. In Hungary, the Hungarian Red Cross is doing its utmost to assist the affected population and help speed up the recovery process.

# MOBILISING OUR CAPACITIES IN UZBEKISTAN AND KYRGYZSTAN



#### Background

On 10 June, 2010, in the aftermath of a series of riots and demonstrations which flared up across Kyrgyzstan in April 2010, violent clashes broke out in southern Kyrgyzstan, primarily in and around the cities of Osh and Jalal-Abad, leading to a massive population movement towards and across the Uzbekistan–Kyrgyzstan border.

#### **Red Cross Red Crescent** action in Uzbekistan

Red Crescent Society of Uzbekistan began responding to the needs of the refugees almost immediately upon their arrival in large numbers. Starting late 11 June the staff and volunteers of the branch provided tents, used clothing and mattresses and began offering hot meals. A wide range of food and non-food items was distributed. Two flights organized by the International Federation arrived to Uzbekistan on 20 June carrying non-food items, a combination of in-kind donations from a number of partner National Societies (Canadian, British, and Danish Red Cross Societies) and International Federation stocks dispatched from the Dubai



#### Thousands flee to Uzbekistan

Following the population movement across the border, an estimated number of 92,000 refugees were registered in Uzbekistan accommodated in camps in the areas of Andijan, Namangan and Fergana. The Red Crescent Society of Uzbekistan, acting as an auxiliary to the public authorities, engaged immediately in the provision of relief assistance to the affected people.

In response to the situation, the International Federation deployed a field assessment and coordination team (FACT), seconded senior Europe Zone Office personnel to Tashkent, issued a preliminary Emergency Appeal, made a DREF allocation of CHF 300.000 - followed on 18 June

Red Crescent. The International Committee of the Red Cross provided support to the National Society and began mobilising in-kind assistance either.

#### The humanitarian scenario switches to Kyrgyzstan

On 24 June, the Government of the Republic of Uzbekistan announced that all refugees, with the exception of 395 individuals who remained as a result of continuing need for medical attention, had returned to Kyrgyzstan and that no further assistance was required. With that announcement, the components of the Movement as well as other international organisations halted their operations and began a reassessment of their role and their plans for the immediate future.

The Humanitarian Country Team estimates the total number of IDPs and returnees in the country at 375,000, of whom most are now with host families. According to OCHA report released on 6 July, the Kyrgyz Ministry of Health confirmed that 180 refugees from Kyrgyzstan still remain in Andi-

#### jan Region of Uzbekistan, while 117 other injured refugees have been transferred to



medical facilities in Osh and Jalal-Abad.

Due to the quickly changed situation there was no distribution of relief items delivered by the IFRC to Uzbekistan: refugees returned to Kyrgyzstan before the distributions could be organised.

The International Federation thus proposed to transfer a proportion of the goods imported into Uzbekistan to Kyrgyzstan, in consultation with the respective donors, while using the remaining part to replenish the stock of the Red Crescent Society of Uzbekistan, that were utilised to support the refugees when they arrived across the border.

#### THE TURKISH RED CRESCENT DELIVERS EMERGENCY HU-MANITARIAN AID FOR THE VICTIMS OF THE CIVIL UNREST IN KYRGYZSTAN

response to the humanitarian emergency caused by the armed clashes in southern Kyrgyzstan on 10 June, the Turkish Red Crescent mobilized itself to provide emergency humanitarian aid - consisting of tents, medical supplies, food and non-food items as well as psychosocial support - to both Kyrgyzstan and Uzbekistan, without any discrimination in accordance with the Fundamental Principles of the International Red Cross and Red Crescent Movement

The relief materials (480 food rations, 300 kitchen sets, 500 blankets and 109 medical supplies) were loaded on a cargo plane which flew to the city of Osh, Kyrgyzstan, on 15 June 2010 from Ankara. The TRC also deployed an emergency response and assessment specialist in Kyrgyzstan, who reached Osh on the same day and immediately started the distribution of the relief materials to the beneficiaries, in the villages of Dyykan-Kyshtak, Jany-Chek, Dostuk, and in the Osh city orphanage "Boorukerdik", in coope ration with the Kyrgyzstan Red Crescent. The Turkish Red Crescent liaised with the Red Crescent Societies of Uzbekistan and Kyrgyzstan and assigned a Disaster Management Coordinator to the region, in order to coordinate the humanitarian activities The second cargo plane, carrying 40 tonnes of humanitarian relief materials (310 family tents, 1200 blankets, 310 kitchen sets and utensils), along with an emergency relief team compo sed of 6 experts, was dispatched to Uzbekistan few days later. As a part of response activities, so as to facilitate recover ry of affected communities, psychosocial support activity ties will be undertaken by Turkish Red Crescent's psychologists on the ground both in Kyrgyzstan and Uzbekistan

As the humanitarian situation remains highly volatile, the Red Crescent Society of Kyrgyzstan, in partnership with the ICRC, continues to provide humanitarian assistance to the most vulnerable victims of the recent violence: it was among the first humanitarian agencies to provide assistance to the affected population through distribution of food and non-food items, medical supplies, hygiene items and materials to repair damaged houses. More than 5,000 individuals received blankets, jerry cans, food parcels. Totally 150 tents to returnees whose houses were burnt

was distributed.

The International Federation has concentrated on the support of the KRCS activities to respond to the emergency situation through allocating resources from the Disaster Relief Emergency Fund (DREF).



#### Fostering partnerships in Kyrgyz-

The ICRC therefore launched its preliminary appeal on 14 June and will launch in mid July its full Budget Extension Appeal for the emergency operation in southern Kyrgyzstan.

Complementary to the ICRC Budget Extension appeal, the International Federation will support the activities and operations of the Red Crescent Society of Kyrgyzstan through an emergency appeal which was launched on 15 July, which is targeting the most vulnerable of the affected households including IDPs and returnees in the areas of psychosocial support, emergency response and early recovery support, and capacity building.

# **RESPONDING TO EMERGENCIES**

## Eastern Europe struck by floods

Large swathes of Eastern Europe, including regions within Ukraine, Romania, Moldova and Bosnia-Herzegovina, have been hit by heavy floods, plunging rural communities into vulnerability.

In western Ukraine, more than a thousand houses have been flooded in the regions of Chernivtsy and Ivano-Frankivsk, though affecting a total of 65,000 people. Some 2,000 hectares of agricultural land have been damaged. together with infrastructure such as roads, bridges, schools and wells. Regional branches of the Ukrainian Red Cross Society have started giving assistance to some of 3,500 people, prioritising those who have been evacuated. Staff members and volunteers are helping people find shelter in community buildings and with host families, providing them with clothes, hygiene items and bedding.

#### Drinking water

The National Society built up fruitful cooperation with Charity Fund "Development of Ukraine" to serve the needs of affected people. Also, Ukraine Red Cross has a cooperation agreement with the Coca-Cola Company, which donated 4,000 litres of drinking water.

CHF 244,126 has been allocated from the IFRC's DREF to support the National Society in delivering immediate assistance to some 3,500 people (1,200 households). IFRC representative for Ukraine, Joe Lowry, noted "these regions are essentially still recovering from the massive floods of 2008. "Fortunately, the local branches are well prepared and have a good working relationship with the local authorities

This allowed them to start helping as soon as the floods hit." While the Ukraine Red Cross concentrates

on humanitarian relief, local authorities are undertaking evacuations, restoring power supplies and checking flood defences. The Russian Ministry for Emergencies sent two transport planes with relief

In Hungary, another several hundred millions of forints are needed to allow the recovery from the floods, after the total number of houses to be renovated has fur ther increased. The Hungarian Red Cross recently received donations in support of the people in need from the private sector: i.e. BASF a chemical company Hungary, donated 7.5 million forints to the Red Cross, and Amway Hungary, a company specialized in health and homecare products, contrib uted with both cash - by raising HUF 1.607.250 among its custom ers - and in-kind donations (deter gents, preserved foods, worth HUF 1,079,537, which were sent to the flood-hit region of Jászság through the Red Cross)

In the last two 19 months, two im- 23 portant First Aid events took place

in Europe: the First Aid Education European Network (FAENN) annual meeting, held between 17 and 19 June. 2010 in Izmir, Turkey, and the First Aid Convention (FACE), which was hosted in Belgrade by the Red Cross of Serbia from 8 to 11 July. "There is one programme that we find in each and every Red Cross Red Crescent Society and that is First Aid. It is our human nature to extend help and alleviate suffering wherever it may occur, without any form of discrimination. At the same time it is also our responsibility and duty to learn, develop, exchange knowledge, improve and constantly practice new skills and keep our First Aid knowledge up to the latest standards", continued Dr. Radovanović in his speech.

The Red Cross Red Crescent Societies are the strongest first aid providers in Europe and in the world, and first aid is an essential tool to achieve the goals of Strategy 2020. These were some of the premises pointed out in Izmir.

As it was outlined during the annual meeting, in order to achieve the second strategic aim of Strategy 2020 - enable healthy and safe living - within the next 10 years, a strong focus on first aid is indeed essential. This includes the implementation of Red Cross Red Crescent guidelines on first aid and resuscitation, further advocacy for the establishment of an International First Aid Certificate (IFAC), the reinforcement

of knowledge and information sharing by NSs with the European Network, as well as advocacy work for first aid to be more accessible on a national level.

The responsibility of National Societies to reaffirm the role of first aid in saving lives and preventing diseases was strongly highlighted in both events. National So-Red Cross, in the opening session of the cieties are encouraged to take initiative

# The 7th Rescue and DM National Training of the Hellenic Red Cross

From 24 of June to 4 July, the 7th Rescue and Disaster Management National Training of the Hellenic Red Cross was held in the Training Centre of Psathopyrgos, near Patras, in Greece. Since 1998, every two years, the Hellenic Red Cross has been organizing such train-

in developing own first aid policy strategy, increasing the number of people educated in first aid by making it more accessible through advocacy work with Govern-

ing in cooperation with the German Red Cross.

This year, the two National Societies celebrate 30 years of collaboration: it was 1980 when, driven by the aim to prepare their volunteers in the fields of first aid, paramedicine, technical rescue and disaster management, they established a jointly-led training system. This collaboration brought a revolution in the field of volunteer training in Greece, by producing the strictest, longest and most complete training system for first aid and rescue in Greece.

The training is the biggest ever performed by the Training Department of the Samaritans. Rescuers and Lifeguards Administration of the Hellenic Red Cross. 210 first aid and rescue volunteers and 25 Instructors from both the Hellenic and the German Red Cross were involved in this 15 day training process.

The fields where volunteers were trained are pre-hospital life support, safe driving of rescue motorbikes, urban firefighting, urban search and rescue and rescue techniques from confined space.

"We are proud of owning the biggest volunteer rescue and first aid force in Greece. We made a revolution in the standards



of Greece, by setting up a solid training system that gives us efficient volunteers ready to save lives and livelihoods" says Mr. Anastasios G. Gerasimatos, Head of Training Department of Hellenic Red Cross.

## Kazakhstan RC: Your Best Defence is You

The International Federation has supported a **community preparedness project** in Kazakhstan RCS, which was implemented between **15 January and 15 July**, **2010**. The main goals of the project were to **increase community preparedness and mitigate the impact of pandemics** in terms of morbidity and mortality, by reducing risks related to health, food security and livelihood. The project was planned in three directions: communication and advocacy, planning for business continuity in case of pandemic and trainings for staff and volunteers.

#### Activities performed

The Kazakhstan RC took care of the preparation of, on the one hand, communication materials for public distribution, i.e. posters and brochures, which were distributed to the three branches involved in the project and, on the other hand, training materials for volunteers and staff, developed basing on the information from www.pandemicpreparedness.org.



Main targets of training were volunteers from targeted vulnerable communities (i.e. multiple birth families, refugees, migrants, students), who after the training started conducting information sessions in their own communities.

In Almaty branch, RCS targeted a total of 850 persons to be educated, and, by mid-April, **350 were trained**. A simple questionnaire in Russian and Kazakh languages RCS branches, a round table was organized with key stakeholders about

The International Federation has 186 members and there is much diversity hidden within that single number.

Some national societies are constituted on the territory of seriously large countries: The Russian Federation, alone, is more than 17 million square kilometres; the ten largest countries by area represent about half of the world's territory. By contrast, the ten smallest independent countries have a combined territory of around 400 square kilometre: a little less than the municipality of Oslo.

As with countries, so with national societies: the term refers to large and small in equal measure.

However, in the International Federation as in other organisations, the media, and among people in general the small get less attention than the big, which is one reason why we are making space in our newsletter for some of the **small European National Societies**.

But: what is small in this context? What is the cut-off point? Pragmatically we have used a population of around half a million as the upper limit: this would give us a European list of Luxembourg. Malta, Iceland, Andorra, Liechtenstein, Monaco and San Marino (the Vatican doesn't have a National Society vet). And how should we refer to these societies? Microsoft Word gives a series of synonyms: little; minute; tiny; diminutive; miniature; petite; undersized: none of these seem entirely right and respectful. For this edition of the newsletter we have landed on a temporary compromise by prefixing "national society" with the word micro, but we should be grateful if readers would help guide us in the future – about the name as well as the cut-off point.

#### THE RED CROSS OF THE RE-PUBLIC OF SAN MARINO

In this journey of ours across the micro national Societies, we will start from the Red Cross Society of the Republic of San Marino, the landlocked enclave entirely surrounded by Italy.

The first branch of the Red Cross of the Republic of San Marino was born in 1915, in the eve of Italy's entry in the First World War, under the name of Delegation of the Italian Red Cross in San Marino. In 1949, the Red Cross of San Marino became an independent organization, in 1950 it was officially recognized by the ICRC and, two years later, it was accepted as a member in the then known as League of Red Cross Societies.

As of 2010, the Red Cross of San Marino counts some 1500 members and 120 volunteers.

"Our volunteers are mainly relief volunteers, but they will soon be joined by a youth voluntary body, due to be established in the near future - said **Mr. Raimondo Fattori**, President of the National Society of San Marino, during a phone interview – Given the extension of the country where we work, we have no local branches, nor paid staff. We base our activity on voluntary work alone".

"Our main activities on the territory focus on medical assistance at sporting events and transport services in agreement with the hospitals of the country", he continued. "Our action has not been affected by

the recent World Financial Crisis, and, in terms of international support, we have built a rest home in Romania, where we also provide assistance to two orphanages. In Albania, our National Society has been involved in the renovation of a hospital, as well as of two health centres in Sarajevo, Bosnia-Herzegovina", concluded Mr. Fattori.

## Sports clubs and community support the Turkish Red Crescent

Founded in 1903, **Besiktas JK**, the first sport club of Turkey, has received many positive comments after deciding to advertise the **Turkish Red Crescent emblem** on the back of their football jersey. During their 106-year-history, the Besiktas JK has blazed a trail in Turkish football history, including this recent decision to be **the first Turkish football club to use the logo of a non-governmental organization on the shirt**.

The Turkish Football Federation gave permission to all football clubs to find sponsorship for the back part of their shirts to support football clubs financially. While other league teams carried their privately owned sponsors' names on their shirts and earned millions of dollars of income, Besiktas chose voluntarily to promote the Turkish Red Crescent.

#### The Hungarian Red Cross promotes Blood Donation

On 14 July, 2010, like every year, millions of people around the world celebrated the World Blood Donor Day.

World Blood Donor Day is dedicated to thanking and celebrating voluntary non-remunerated blood donors and one of its main goals is to ensure the availability of 'safe blood' for transfusion. On this day, the Hungarian Red Cross held special cel-

ebrations in Pécs, famous for being designated as one of the three European capitals of culture for 2010. "This day is a very special day for our National Society – said **Ms. Eva Koltai**, Head of the Blood Program of the Hungarian Red Cross – A day when we want to thank all those million people across the world who every year give their blood to save lives".

The Hungarian Red Cross has been active in blood donor recruitment since 1939 and, from 2000, based on an agreement with the **National Blood Transfusion Service** and through more than 11,000 blood donation events per year, it recruits over 430,000 voluntary, non-remunerated blood donors annually.

The first Hungarian mobile unit for blood donation and collection started its operation on 30 August, 2006. This mobile unit is set up in important places such as busy crossing points, housing estates, and the car parks of shopping centres, where a sufficient number of potential donors can be approached.

This year, the slogan "New blood for the world" put further emphasis on the importance of youth as key actors in the spread of blood donation among their peers and in the promotion of healthy lifestyles as a sign of accountability.

> Youth start getting in touch with blood donation from primary school, where they receive training sessions and get involved in the organization of events, in awareness-raising and donors recruitment. In 2004, the HRC established a national higher education blood donor competition, seeing high schools and universities running for a youth award, which is granted to the institution with the highest number of young donors.

> And in 2009, a programme for the promotion of healthy lifestyles in kindergartens was also launched, which can also help involve families with the help of their kids.
